Countries mandating face masks have shown that it assists in reducing the spread of COVID-19. Germany's Chancellor, Angela Merkel, has a PhD in quantum chemistry, and has assisted Germans in understanding the science behind COVID-19. At the beginning of the pandemic, Merkel explained that masks will be difficult to access, so Germans began making their own face coverings. Merkel provided public updates based in scientific research. As Merkel is not known for her empathy, she is seen as being objective, showing little political biases in her response to COVID-19. Germans also seem to be less focused on their freedoms and civil rights as opposed to most North Americans, and are less culturally individualistic, more willing to make concessions towards the greater good in comparison to Americans. Similarly, Germans have a longer-term orientation, being more willing to delay short-term success and emotional gratification in preparation for the future.¹

So why are some people so adamant about not wearing a mask? Other reasons for not wearing masks is a feeling of claustrophobia, and others may perceive the reaction to COVID-19 as overblown and thus do not feel that mandatory masks are a reasonable reaction, thus refusing to wear it. For some, the reason is more than just one factor. When people's freedoms are violated, or a perception of such, a psychological reaction called psychological reactance occurs. This moral outrage, characterized by extreme anger, occurs as they feel that their rights are being tread on. During the 2018 Spanish Flu, similar refusals to wear masks occurred by some who felt their civil liberties were being violated. For those that are usually anti-government or anti-establishment, government orders are nothing more than "coercion" and "control", thus politicizing masks. As we are all experiencing a collective trauma of sorts, and many have reported feeling on edge and stressed, many of us are in a "fight or flight" response. When faced with a sudden threat from an unknown threat, this leads to a concept called "hot cognition", where strong emotions override our rational thinking system, causing us to react instead of responding.

In many countries, health officials were at first dissuading individuals from wearing masks, likely in an effort to safeguard enough mask supply for healthcare workers. Later, as directives changed and with masks not only recommended but mandatory in many jurisdictions, regular individuals who do not understand the science, may lose faith in health officials. Furthermore, when similar experts from different locations have different recommendations, it is hard for many to decipher why the change in directives occur and which information is what they should act on. Extensive understanding of research methods is integral to being able to assess scientific studies, and with results being discussed in social media before being peer reviewed prior to release people become confused.

A downside of having low infection rates is that citizens do not witness the real-life consequences of COVID-19. Those who do not have first or second-hand knowledge of someone who was sick, which is often the case in areas with a low infection rate, may wonder why such measures were necessary since infections were low. As can be

seen in places such as Israel, explosive growth of the virus can occur quickly, and it is difficult to tell how many people are infected because tests look at historical data and struggle to provide a timely and accurate view of the present state of infection. It is directly due to the tough measures that some locations have low infection rates. Unfortunately, some use this as a reason as to why measures should be reduced or removed all together. Those in harder hit areas appear to be, on average, more willing to make concessions towards reducing the spread. If masks are presented as a patriotic practice, or a duty to other citizens, it may be that more individuals will become comfortable with masks as a hygienic practice, a routine practice in many Asian countries.

- Canadian health officials are warning that with Canada's increasing cases, it is possible Canada is heading towards a spike in the virus, with little time for measures before increased growth. It is believed that the reopening of bars and clubs may signal to individuals that the danger has passed.
- Ontario has seen a recent spike in COVID-19 cases, but yesterday reported a lower rate (104) of new infections. Most of the infections were recorded in the areas which have not moved into Phase 3 of reopening plans; Toronto, Peel Region, and Windsor-Essex. An increase in hospitalizations has also been identified, although no deaths were recorded on Thursday.
- BC has experienced a spike in cases, with more than 30 cases over the last few days. Although no deaths were
 reported for about eight days, BC has put new measures on bars, clubs and restaurants. All patrons must be
 seated, with no alcohol self-service and no dancing. BC is also looking into regional only restrictions, possibly
 placed on Kelowna as that specific outbreak reaches over 78 infections. BC has launched a website which
 contains public exposure warnings in case contact tracing cannot be completed.
- BC is spending an additional \$1 billion for COVID-19 relief, matching federal funds for public transit and municipal governments. This is in addition to the \$5 billion previously announced, a \$12.5 billion deficit.

On Thursday, the USA officially passed the four million COVID-19 infections mark. Currently, just under • 145,000 people have died from COVID-19 in the USA. Hospitals in areas such as south Texas, Arizona, Southern California, Florida, and Louisiana are experiencing overflowing hospitals where some patients not believed to have a high chance of surviving are being refused access to hospitals. Daily death counts are also their highest since May.
